Project Title: Ely Cemetery Tree Maintenance and Removal

Scope of Work: (Total staff on site=5)

### 1. Tree Removal

Removal of eleven (11) large, complex trees at Ely Cemetery.

 Utilize experienced 3-man bucket crew (2019 Freightliner M2 75ft aerial lift) consisting of a Journeyman Climber/bucket operator and groundsman. All of our trucks travel with BC1000XL 12" capacity wood chippers.

 Wood management will be handled with our 2023 Peterbilt 567 Self loading grapple truck. This will allow us to pickup and transport entire sections of the trees.

### 2. Stump Grinding

Grind stumps of the same eleven (11) trees to below ground level.

Qualified equipment operator running a tracked 37HP Rayco Stump grinder.

### 3. Tree Pruning

 Pruning of additional trees for corrective health as determined by the Public Works Director.

### Project Approach:

### Pre-Project Planning

- Conduct a thorough site assessment to evaluate the condition of the trees and identify any potential hazards.
- Coordinate with the Public Works Director to finalize the list of trees for removal and pruning.

### **Equipment Mobilization**

Arbor Pros has an existing contract with White Pine County for the removal and stump grinding of (7) trees at the Courthouse, 0.9 Miles away from the Cemetery. We currently plan to mobilize to Ely around the 3<sup>rd</sup> week of August for the White Pine County Project. The identical resources would be necessary for the City of Ely Cemetery project. Chayce Cassani, the owner of Arbor Pros has relationships with several locals in the Ely area that have available Air B&B's for staff. Arbor Pros would be optimistic about extending our stay a week or so to complete the cemetery project as well. The benefits here would be that the mobilization and demobilization are already factored on a separate project and would not need to be billed to the City.

- Mobilize necessary equipment, including chainsaws, stump grinders, and safety gear.
- Ensure all equipment is in excellent working condition and free of fluid leaks.
- As we are already mobilized in Ely for the courthouse project, our equipment is onsite and ready for immediate deployment.

### **Tree Removal Operations**

- Crew Structure: 3-man crew will consist of a Journeyman responsible for cutting/climbing and an additional climber as well as groundsman responsible for assisting with debris management. The equipment operator that runs the Stump grinder will be on site to aid the tree crew throughout the project.
- Tree Felling:
  - Trees will be directionally felled and or "pieced out" to avoid damage to nearby graves and structures. Arbor Pros has worked at numerous cemeteries in the past, most recently the Northern Nevada Veterans Memorial Cemetery in Fernley, NV where trees need to be taken apart strategically, with technical rigging and care to prevent damaging grave stones and other targets.
  - The sawyer will make precise cuts to control the fall direction, and utilize rigging ropes, blocks and pulleys to eliminate free falling material when necessary.
- · Limbing and Bucking:
  - Limbs will be removed, and trunks will be bucked into manageable sections.
  - All debris will be neatly stacked for removal or further processing.
- Stump Grinding:
  - Stumps will be ground to below ground level to allow for future landscaping or replanting.

### **Debris Management and Cleanup**

• Wood Chips: Productive use of wood chips will be planned for the White Pine County Golf Course, as we are currently doing for the courthouse project. We will













already be working with the Golf Course from the courthouse job so we will follow suit and continue donating chips to the course.

- Cord Wood Donation: Cord wood donation can be through our existing contact from the White Pine County contract. All wood will be donated through our existing relationship which provides the wood to low income households. Wood will be transported with our 2023 Peterbilt 567 Self loading grapple truck. Based on the letter from Bill Wolf, the Chairman of the Ely Tree Board we understand there may be some special requests for large sections of trees, or the difficulty in transporting them, we feel we could offer solutions. We have the means to move large logs with the equipment, if the goal is to preserve them for future uses. On the other hand, we could also buck these logs into smaller sections to be processed easier for firewood by Randy Ewell. Lastly, if there are logs to large and not desired, we have contact with several members of the community that work for a local Hunting Outfitter that would be happy to take some logs.
- Site Restoration: The work area will be thoroughly cleaned, and any disturbances will be restored to their original condition.

### Quality Control Plan

- Daily Inspections: Daily inspections by the project manager to ensure compliance with the SOW and safety standards.
- Communication: Regular updates to the Public Works Director to address any concerns promptly and reduce the need for Government oversight.
- Safety Protocols: Adherence to strict safety protocols to prevent accidents and injuries. All crew members will wear appropriate PPE.

### **Post-Project Reporting**

- Final Inspection: A final inspection will be conducted with the Public Works Director to ensure all work has been completed to satisfaction.
- **Documentation:** Submission of a detailed report documenting the work performed, including before and after photographs.

### C. Scope of work:
