#### 2. PUBLIC COMMENT:

George Chachas stated on your agenda item 3C-1 you are to consider the White Pine County Youth Centers Will-Serve to connect the water line for its temporary safe housing duplex to the existing buildings water line at 399 1st Street; that needs to be denied. The City has a policy requiring every structure to have its own line. The city has set precedents in the past when they litigated against Ilma Blackmore that had property in which two houses shared the same sewer and water connection that had been that way before she purchased the property and was grandfathered in. However, the City forced her to establish two separate connections. The City cannot discriminate in any federally funded or assistant public utility. On your agenda item 3C-2 you are to consider the recommendation to remove past the utility penalty fees in the amount of \$7,409.39. I'm not against the write-off, but I want equal protection and consideration under the law. Recently I purchased the property at 827 Avenue D and tried to change the billing to me and at the same time pay for any landfill fee that was due. I was denied, because I did not have the deed at the time. I received a letter from Mayor Robertson, dated October 17, 2024, stating that I have to pay in full the back billing of \$114.11 before I can apply and receive the outstanding penalty balance of \$4.27 to be waived. I remind you again that I paid for my property at 490 High Street, as instructed in the letter from City Clerk Jennifer Lee, dated November 25, 2019. and I did not get the same consideration. The City to date has failed to reimburse me for the overpayments that I made at the old Ely Grade school at 622 High Street. You wrote off the back billing for young Tom Bath when he bought the hotel, and I want the same consideration. The City gave property owners at 790 Avenue I a \$4,000.00 or more write-off. It was an employee error to justify the write-off even though the utilities were used for years.

Robinson continues to mine from both the Ruth and Liherty pills. The fallowing is a breakdown of fresh water dewatering efforts from the South Block:

Approximately 6,568 gpm is being pumped, 1,785 gpm is going into Cleason Creek and the fest is going to the Mill for ore processing. RW-7P is delivering approximately 1,059 gpm into the city water system.

#### C. NEW BUSINESS

Board Members – City Engineer Almberg – Discussion/For Possible Action –
Recommendation to approve White Pine County Youth Center's Will-Serve Application

City Engineer Almberg stated you have the running calculation based on the number of services and connections we have, and we are in good shape for this. They have paid for both the water and sewer connection; I recommend approval.

City Clerk Lee stated for the record, after the Utility Board made the recommendation to allow them to connect to the existing water line for the other building, the Council did approve that. This is just formalizing it because they did submit an application and paid for the Will-Serve.

Vice Chairman Derbidge moved to recommend approval of White Pine County Youth Center's Will-Serve Application to connect the water line for its Temporary Safe Housing Duplex in APN 001-163-07 to the existing building's water line at 399 First Street. Member Ross seconded the motion. The motion carried unanimously.

They're the ones as well as the previous board that went after Mrs. Blackmore. It is wrong; they need their own separate connection.

City Clerk Lee stated Mr. Jones paid the Landfill fees in full on the 17th of this month, which were \$2,178.32 and he's requesting a waiver of the penalties in the amount of \$7,409, 39.
